ORDER

Ministry of Environment & Forest & CC, GoI has notified the Battery Waste Management Rules, 2022, in the Gazette of India, Extraordinary, Part II - Section 3 - Sub-section (ii), vide S.O. 3984(E), dated the 22nd August, 2022 in supersession of the earlier Batteries (Management and Handling) Rules, 2001.

As per the provisions of the Batteries (Management & Handling) Rules, 2001, "Registration for Dealers of the Lead Acid Battery" was included in the service of the West Bengal Pollution Control Board. The Dealers of the Lead Acid Battery apply in the Online Consent Management & Monitoring System (WBOCMMS) of the West Bengal Pollution Control Board for obtaining registration.

The Battery Waste Management Rules, 2022 specified that entity involved in refurbishing and recycling shall register through centralized online portal of Central Pollution Control Board (CPCB). Accordingly CPCB / SPCB will issue registration.

Therefore, "Registration for Dealers of the Lead Acid Battery" under The Batteries (Management & Handling) Rules, 2001 shall be no longer relevant.

Now, in suppression of all previous relevant orders in this regard, it is hereby directed that refurbishers, recylers of Batter Wastes henceforth shall apply for registration (new / renewal) in centralized portal of CPCB.

No application for registration (new / renewal) for Dealers of Lead Acid Battery under the Batteries (Management & Handling) Rules, 2001 in WBOCMMS shall be entertained.

This order will take immediate effect.
